Report on the financial statements

We have audited the accompanying financial statements of Society For All Round Development, which comprise the Balance Sheet as at 31 March, 2018, and the Statement of Income and Expenditure for the period from 1 April, 2017 to 31 March, 2018, and a summary of significant accounting policies and other explanatory information.

Management's responsibility for the financial statements

Trust management is responsible for the preparation of these financial statements that give a true and fair view of the financial position, financial performance of the trust in accordance with the accounting principles generally accepted in India, including accounting standards. This responsibility also includes the maintenance of adequate accounting records in accordance with the Accounting Standards as prescribed by ICAI for safeguarding of the assets of the Trust and for preventing and detecting the frauds and other irregularities; selection and application of appropriate accounting policies; making judgments and estimates that are reasonable and prudent; This responsibility further includes the design, implementation and maintenance of internal control relevant to the preparation and presentation of the financial statements that give a true and fair view and are free from material misstatement, whether due to fraud or error.

Auditor's responsibility

Our responsibility is to express an opinion on these financial statements based on our audit. We conducted our audit in accordance with the Standards on Auditing issued by the Institute of Chartered Accountants of India. 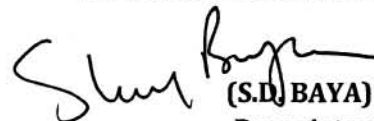

- a) Balances of Liabilities towards funding agencies, Recoverable from funding agencies, Advances, Deposits etc. are subject to confirmation.
- b) As per decision of Executive Committee, the Sansthan has written off old balances receivable and payable in the pervious year, which, in the opinion of the Executive Committee, are not payable/receivable as of today. The balance of amounts written off has been credited to the Income & Expenditure Account during the previous year NIL.

6. Retirement benefits to Employees:

The Sansthan has not maintains its Gratuity Fund.

Reserves and Surplus:

In accordance with a decision of the Executive Committee, the Surplus or Deficit of Income & Expenditure Account is transferred to Corpus Fund every year.

7. Provision for Taxation:

The income of the Sansthan is exempt u/s 11 of the Income Tax Act, 1961 and hence no provision for taxation has been made in books of accounts.

8. Contingent Liabilities:

All Liabilities have been provided for except contingent liabilities.

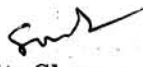

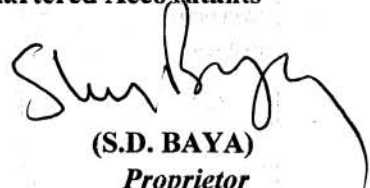
